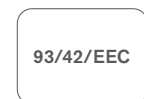
## ISO 13485:2016 – Medical Device Quality Management Systems

## 93/42/EEC – the Medical Devices Directive, 2017/745 – Medical Device Regulation

Access into European markets is made possible by certification to the Medical Devices Directive and Medical Device Regulation. This enables CE marking of all Intersurgical products. The combination of certification to this Directive and ISO 13485:2016 is accepted for market entry in many countries.



## FDA 21 CFR 820 – Quality System Regulation, USA

All Intersurgical manufacturing sites are registered with the Food and Drug Administration (FDA), which enables Intersurgical products to be sold in the USA.

## ISO 14001:2015 – Environmental Management Systems

Customers are increasingly demanding environmentally responsible products and services.
